KEY TOPICS EXECUTIVE SUMMARY

Telehealth

AMA: Key points: location of person should not matter - **Telehealth Modernization Act 2021**; eliminate "unnecessary" requirement of person receiving mental health via telehealth has to see provider in person every 6 mos. - **Telemental Health Care Access Act**

- **AANP**: supports telehealth and holds that these health care services are not a separate specialty or the practice of any one profession. Health care provided via technology should be recognized, regulated, and reimbursed on parity with the same services delivered in person.
- APTA, AOTA, ASHA: Expanded Telehealth Access Act HR 3875, S 2880 Aims to make telehealth services permanently covered for therapy practitioners under Medicare.

Bipartisan bill for PT and PTA to continue telehealth services permanently. This bill would permanently give OTs the ability to serve Medicare beneficiaries via telehealth Introduced by Reps. Sherrill, Harshbarger, and Sens. Daines, Smith

FOTA: Licensure Compact In 2022, AOTA joined by NBCOT embarked on state legislation to create an occupational therapy licensure compact. To date, 20 states have passed legislation enacting the compact. Florida has not yet joined the compact, however FOTA is interested in starting the conversation to pursue a compact in future Legislative Sessions.

TOTA: Update from August 10, 2022- House Bill 4 Telecommunications Telehealth will no longer be allowed for ECI services and has ended on June 15, 2022. See more at link https://www.tota.org/assets/LegislativeInfo/HHSC/early-childhood-intervention-policy-hb4-public-comment-responses.pdf

- PT, OT, ST Services, and related Durable Medical Equipment Services. Audio (phone) calls will no longer be billable for DME education however, telehealth is still covered. For more info see link https://www.tota.org/assets/LegislativeInfo/HHSC/therapy-policies-hb4-public-comment-responses.pdf

Mental Health

Occupational therapists are recognized at the federal level as mental health providers and while they cannot diagnose, they work with those to create treatment plans and provide appropriate and valuable treatment. OTs provide mental health services in a diverse range of settings, including community-based home health care, hospitals, schools, nursing facilities, and private practice.

AMA: Telemental Health Care Access Act - See above

AOTA: Occupational Therapy Mental Health Parity Act - This bill was introduced to the Senate and would expand access to OT services for mental and behavioral health disorders under Medicare and Medicaid

Mental Health Professionals Workforce Shortage Loan Repayment Act - this Act will expand access to mental health services and increase opportunities for occupational therapy in mental health. Action needed

TOTA: school-based practitioner's advocacy efforts for mental health as required by **Every Student Succeeds Act of 2015**.

FOTA: . Florida passed legislation in 2022 to update the OT practice act and recognize OTs role in mental health.

APTA, **AOTA**: Current legislation: **SAFE Act – HR 7618** Stopping Addiction and Falls in the Elderly Act. Aims to Expand and increase access to falls screen and prevention. Welcome to Medicare annual wellness visit with PT or OT.

Workforce Diversity

AOTA, APTA, ASHA: Allied Health Workforce Diversity Act (H.R. 3320/S. 1679) - this Act would provide grant funding to increase opportunities for students from underrepresented backgrounds, including racial and ethnic minorities, in the professions of OT, PT, respiratory therapy, SLP, and audiology.

ANA: Diverse workforce programs to educate nurses to practice in rural and medically underserved communities

Referral, Billing, & Reimbursement

AOTA, APTA, ASHA: On March 9, 2024, President Biden signed the *Consolidated Appropriations Act of 2024*, which includes a +1.68% increase adjustment to the 3.37% conversion factor cut for the remainder of the 2024 calendar year. This still is not enough and there is more work to do.

Additional Rehab proposed legislation for 2024:

- Stopping Addiction and Falls for the Elderly (SAFE) Act (H.R. 7618) bill would add falls prevention services provided by an OT or PT to the Medicare annual wellness visit if a beneficiary has experienced a fall in the last year.
- Telehealth Modernization Act (H.R. 7623) bill would make OT, PT, SLP providers and assistants permanent Medicare telehealth providers.
- Medicare Home Health Accessibility Act (H.R 7148) bill outlines the crucial role of OTs in preventing rehospitalizations and helping people to remain and thrive in their homes.
- Strengthening Medicare for Patients and Providers Act HR 2474

Pre-Authorizations

- **AMA:** Reducing burdens overall **Improving Seniors' Timely Access to Care Act** (H.R. 3173/S. 3018) implements standardized electronic auth program nationwide, transparent prior auth plans reviewed annually
- **ASHA:** Working on helping congress with increased access to Audiologists without physician referral, though the current proposal decreases beneficiary access and increases financial risk to patients and audiologists.
- **AOTA:** New coding for reimbursement (CPT codes 96202, 96203, 97550, 97551, and 97552) for therapy practitioners to train and involve one or more caregivers to assist patients with certain diseases or illnesses in carrying out a treatment plan, without the patient present.
 - A regulatory change to the supervision requirements of therapy assistants from *direct* to *general* supervision, allowing for remote therapeutic monitoring (RTM), for licensed practitioners in private practices.
 - Telehealth therapy services delivered to individuals in their homes will be compensated at the non-facility rate, utilizing modifier "95", when the clinician is in the hospital or outpatient facility while the patient is at home.
 - *** Waived PAYGO budgetary legislation, preventing a possible 4% payment cut for Medicare providers.

Education

Occupational Therapy: Mental Health Professionals Workforce Shortage Loan

Repayment Act - this Act will expand access to mental health services and increase opportunities for occupational therapy in mental health. Action needed

Nursing: HRSA (Health Resources and Services Administration): announced the availability of \$15 million to grow the nursing workforce, improve access to nursing education, and

advance health equity. *****The need for nursing preceptors is limiting admissions to nursing schools; as a result, \$10 million of the fund is earmarked for clinical nursing faculty and preceptors.

H.R. 728: Title VII Nursing Workforce Reauthorization Act of 2019. Nursing workforce development programs including loan repayment & scholarships for nurses, loans for nursing faculty development, advanced education nursing grants, grants for increasing nursing workforce diversity, & nurse education practice & retention grants. Action item: Extension beyond FY2024 is sought to provide for the projected 194,500 average annual openings for registered nurses between 2020 and 2030.

FOTA: Medicaid reimbursement levels for occupational therapists in Florida are amongst the lowest in the country, despite the fact that occupational therapists are a key factor in reducing health care costs, improving quality of life, and helping people return to work.

 Occupational therapy has been shown to have a statistically significant relationship to lower 30-day readmission rates for primary health conditions such as heart failure and pneumonia, as well as reduce hospital length of stay for intensive care patients, resulting in cost savings for the health care system. Support increased reimbursement rates for Medicaid providers and specifically occupational therapists.

- o Oppose a 4.5% Medicare cut to the SLP outpatient services
- The Stop CMV Act (H.R. 7542/S. 3864), a bill submitted in both the House and the Senate, would support state-based cytomegalovirus (CMV) screening programs at the federal level to enhance early diagnosis and intervention. The bill "will focus needed attention and resources on screening for congenital cytomegalovirus in newborns, a huge step forward in identifying children at risk for hearing loss, communication disorders, and developmental delays," according

to a press release from the sponsors, which quoted ASHA President Tena McNamara.
